





Graduate Student Award Application to Attend the 67th Lindau Meeting

Meeting with Nobel Laureates from the field of chemistry

25 June - 30 June 2017

To be eligible, a student must have completed by June 2017 at least two academic years of study toward a doctoral degree in the field of chemistry or related discipline, but not be planning a dissertation/thesis defense before December 31, 2017; be currently enrolled at a university as a full-time graduate student; and must be participating in a research project. A nomination should be initiated by the student or the student's research advisor and submitted by the leader of the institution or their designee.

Nomination Requirements:

The complete nomination includes (1) this form; (2) a personal resumé of the student; (3) a one page statement by the student on why participation in the meeting is important for the student's graduate education; and (4) a strong letter of reference by the student's research advisor with the included questionnaire.

Nomination Process:

The student's research advisor should transmit the nomination form and other required documents to their institutional leadership for consideration as one of the institution's nominees. The institution may make two nominations for consideration. The institution's nominations are then submitted by the institution leader (and not by the student's research advisor).

Nomination packets are to be submitted by email: lindau@orau.org.

An award to the Lindau Meeting is dependent on a final selection process by the Lindau Meeting. Final award announcements will be made by the Lindau Meeting early in 2017.

Sponsorship:

The costs associated with selected students' travel will be covered by Oak Ridge Associated Universities (ORAU). This includes, but is not limited to, airfare, lodging, meals, and ground transportation. In some instances, support for the student participation fee (registration fee) for the Lindau Meeting may be provided by a third-party donor to the Lindau Foundation, and that donor may be a foreign institution. In these instances, the student will be notified of this funding arrangement in advance.

All official institutional nomination packages must be submitted by 4:00 p.m. EST on Friday, October 14, 2016.
